
a. Coach Keith Flewelling



Jeff Hemmen:

Jeff worked at Microsoft in the legal department for 15 years before leaving in 2008. For a period of 7 years, he was a small business owner of a Cold Stone Creamery shop in Factoria Mall. More recently he has worked for Aon Insurance as a consultant for Intellectual Property Valuation. He currently has a G07 ECNL player in the club today and had twin daughters who graduated HS in 2016 (birth year 1997). The Pac alumni pursued their collegiate soccer careers at Virginia Tech and Montana St. Billings, and obtained their 4 year degrees. One is a Biology major and was just recently accepted at UW Medical School, and the other has a full time job using her biomedical engineering degree working for Abott Labs in Portland. Jeff's twin daughters joined GRFC in their inaugural year 15 years ago, playing at U10, and his younger daughter started in the junior program as a U7 player 9 years ago. Jeff has seen firsthand how the club develops players and how their soccer experience prepares them for life after soccer.
